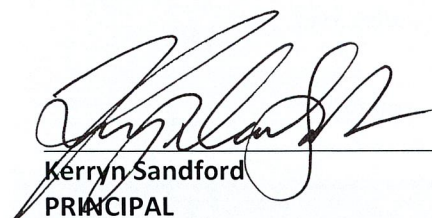
Parent voluntary contributions play a crucial role in supplementing government funding and supporting our extended learning programs, specialist staff, equipment, and facility improvements. They directly impact curriculum programs, technology maintenance, and grounds enhancements, which are critical to maintaining and enhancing the colleges' high standards and meeting the needs of our diverse student body. To ensure transparency, parent contributions are broken down into different components, each serving a specific purpose:

- The curriculum component supports our participation in School Sport Victoria competitions, enhances our Visual and Performing Arts programs, and enables the delivery of specialised programs such as the Year 9 Life Program and the elective programs for Years 9 and 10. Additionally, it supports senior students through career counselling, pathways guidance, tutoring, mentoring, and guest speaker presentations
- The Computer Technical Support contribution ensures the employment of dedicated technology support staff who manage our servers, wireless networks, website, information and communication technology facilities (including the Compass learning management system), and the provision and maintenance of nearly 700 notebooks, tablets, and other devices for students and staff
- The grounds maintenance and improvement contribution has enabled us to undertake significant landscaping projects and replace old seating with modern and aesthetically pleasing alternatives, enhancing the overall safety and appearance of our College.

It is important to stress that the viability of our innovative programs in 2026 relies on your support through voluntary parent contributions. We understand the financial challenges faced by families, and we want to assure you that all contributions are valued and go directly toward student programs, specialist staff, and facilities that benefit everyone. Refunds

- All Camps, Excursions and Incursions are fully self-funded.
- Refer to the school website 'Refund for Activities' under the Payment Policy section.
- On site activities and incursions at the College will not be refunded in the case of absence or withdrawal.
- One day excursions will not be refunded in the case of absence or withdrawal.
- Sports Academy Refund Policy-as outlined in the Heathmont College Sports Academy Student-Athlete & Parental Agreement form.
- Camps – In the case of illness or withdrawal there may be chance of a partial refund where a camp provider is willing to refund the camp cost for your child. A written statement from a parent is necessary with a bona fide excuse. A request of a supporting medical certificate will be required.
- Tax Deductible Donations are unable to be refunded once an office tax-deductible receipt has been issued.
- Instrumental Music – Where a family has requested a refund for any part of the Instrumental Music fee, consideration will first be given to the costs incurred by the school in planning and arranging Instrumental Music Instruction and the cost of any non-returnable items provided to the student.

FREE INSTRUCTION

- Schools provide students with free instruction and ensure students have free access to all items, activities and services that are used by the school to fulfil the requirements of the Curriculum. This includes the Victorian Curriculum F-10, the Victorian Certificate of Education (VCE) including the VCE Vocational Major and the Victorian Pathways Certificate.
- Schools may invite parents to make a financial contribution to support the school.



PARENT PAYMENT REQUESTS

Schools can request contributions from parents under three categories:

Curriculum Contributions

Voluntary financial contributions for curriculum items and activities which the school deems necessary for students to learn the Curriculum.

Other Contributions

Voluntary financial contributions for non-curriculum items and activities that relate to the school's functions and objectives.

Extra-Curricular Items and Activities

Items and activities that enhance or broaden the schooling experience of students and are above and beyond what the school provides for free to deliver the Curriculum. These are provided on a user-pays basis.

- Schools may also invite parents to supply or purchase educational items to use and own (e.g. textbooks, stationery, digital devices).



FINANCIAL HELP FOR FAMILIES

- Schools put in place financial hardship arrangements to support families who cannot pay for items or activities so that their child doesn't miss out.
- Schools have a nominated parent payment contact person(s) that parents can have a confidential discussion with regarding financial hardship arrangements.



SCHOOL PROCESSES

- Schools must obtain school council approval for their parent payment arrangements and publish all requests and communications for each year level on their school website for transparency.

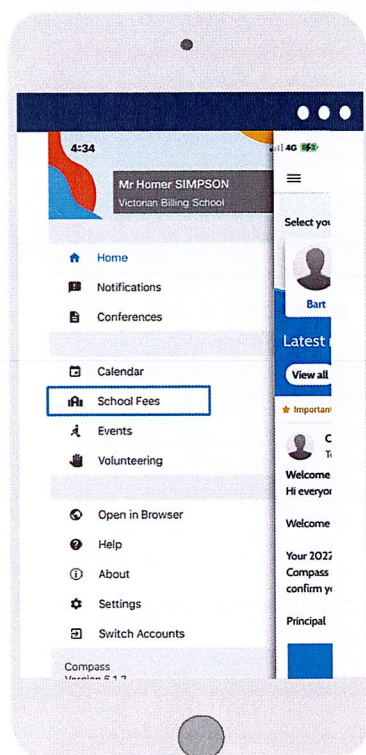

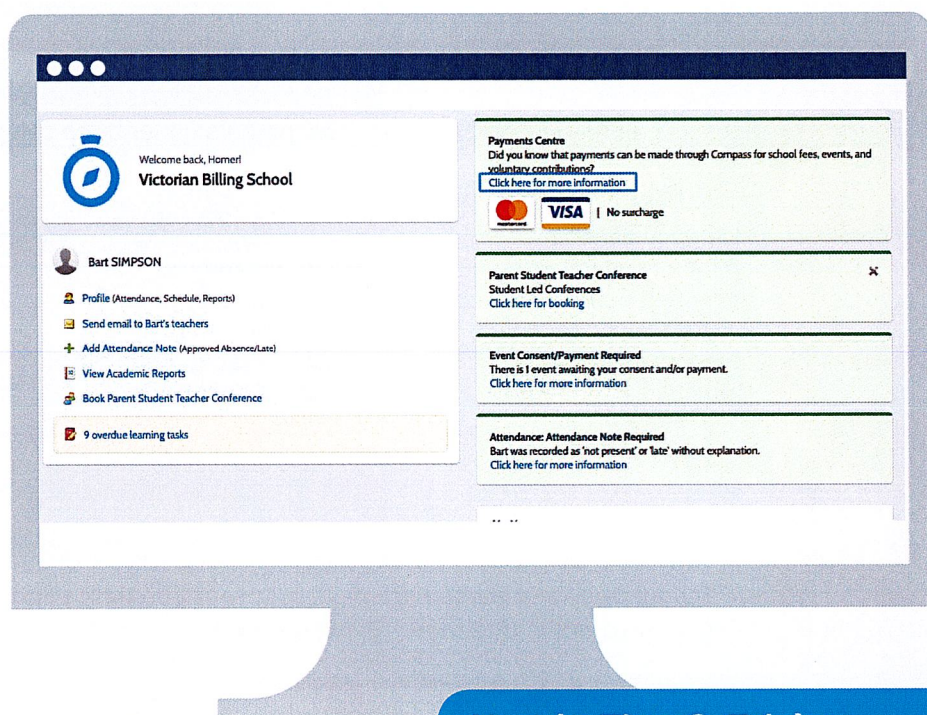

2022 School Payments

Dear Parents and Carers,

High School is proud to offer a range of exemplary curricular and co-curricular programs to students across the school. While the Victorian Government supplies most of the school's funding, this is not sufficient to meet all the costs of the school's programs. All schools are dependent on locally raised funds to supplement government funding for curriculum programs, school services and resources. Locally raised funds in the form of parent contributions are essential for the operation of the school's extended learning program, specialist staff and the provision of additional equipment.

Parent Payment Policy

The Department of Education and Training (DET) Parent Payment Policy provides advice on the different types of payments that schools may request from parents and outlines the procedures and protocols to which schools must adhere. The high school council is responsible for developing and supporting a school-level parent payment arrangement that is compliant with the Department's policy. The DET policy is available here <https://www2.det.vic.gov.au/parent-payment/policy> or a hard copy is available on request from the general office.

Financial help arrangements

High School offers a range of supports to families who are experiencing financial hardship and are unable to make the parent payment. The DET also provides a range of supports to families that will complement the school's programs. The school-based arrangements could include establishing payment instalment plans and providing access to school resources. The DET's arrangements include access to a range of government-funded support programs including the State School Relief Fund, the Camps, Sports and Excursions Fund (CSEF) as well as a range of student scholarships. Families should contact the school via 9092 7600 to enquire about these supports.

The high school council wishes to ensure that increases in parent payment contributions are minimised. However, it cannot be too strongly stressed that the viability of many of our innovative programs is dependent on your support via the payment of the voluntary parent contribution. Payment of the parent contribution is preferred at the time of course confirmation and payment of the school fees.
